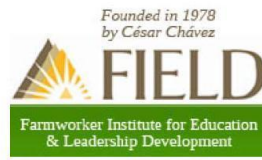

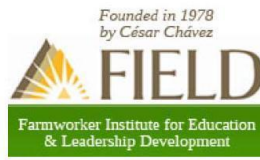
7. CLOSED SESSION
