There is very limited board discussion, between the board, except to ask questions or refer matters to staff, and no action will be taken unless listed elsewhere on the agenda or on a subsequent agenda.

Mr. Villarino reminded the board members about Tax Fom 700 which is state law that requires any board members from nonprofits have to submit the form 700. This form does not go to the Nevada County it will stay in our main office and it is now required to have them on file.

Mr. Villarino continued to inform everyone that we are going to be celebrating Cesar Chavez's birthday on March 31. Staff, tudents and corpmembers are invited to enjoy a free breakfast. We will be honoring the honorable Supreme Court Judge Marcos Camacho, who was a longtime general counsel for Caesar and the United Farmworkers. He went into private practice probably about 10 years after Cesar passed away and then he was appointed Supreme Court judge by Governor Brown so we're going to be honoring him with the Cesar Chavez Legacy Award.

In addition, on April 9, 2022 we are planning a FIELD festival as an open house. Things are progressing very well. We now have funders to close escrow on the 11 acres in Bakersfield where we will put our career technical education programs. We will have informational booths, food, music as well as speakers. The community will be inviting the community at large. Our new facility is located on 2240 South Union Avenue in Bakersfield, CA 93307.



Mr. Villarino shared his final item which is the purchase of our new facility is located on 2240 South Union Avenue in Bakersfield, CA 93307. We are currently in escrow we have two lenders, one is the primary and one is the secondary the secondary will subordinate on the loan our primary lender is specific funding. They're located in Monterey Park in Southern California. They have an they have provided an intent to loan \$2.4 million in in monies to help fund the Union Avenue Project and then we are working with Nonprofit Finance Fund which is located in the Bay Area, they are working on underwriting \$600,000 towards the purchase of the property. Currently right now we're in the underwriting process with both of them we're doing going through due diligence. The target is to get to docs by March 25th and trying to get all of our conditions cleared in order to draw docs, the Monday prior to closing and fund escrow by the 30th.

And with that, we intend to place all our career technical education there which includes our recycling & Early Childhood Education. Half of the office space will be assigned to adminstration and the other half we want to convert into transitional housing with about 20 dorms, as we may potentially place those students of ours who are recently emancipated from foster care or that are homeless or that have transportation issues.
